Annual enrollment for your 2025 benefits is Monday, October 14 – Friday, October 25. This is your opportunity to review and choose the benefits that work for you and your family.

What's changing for 2025?

Medical Plan Contributions

Lubrizol will continue to offer the Core, Standard, and Plus medical options in 2025. Contributions for the Core and Plus medical options will increase moderately in 2025. The amount will vary depending on the coverage level (i.e., individual, 2-person, or family) you elect.

Prescription Drug Change – Brand-name Drugs Only

Lubrizol is making a change to prescription drug coverage that might affect you if you are taking a brand-name medication. You might experience a noticeable change in the cost you pay for your brand-name medications — either higher or lower. If you are affected by the change, you will be notified by CVS Caremark. Please read the communication carefully, and visit the CVS Caremark website or call the number on the back of your CVS Caremark ID card for questions.

Dental Plan Contributions

Contributions for dental coverage will increase slightly.

Health Savings Account (HSA) Contribution Limits

You can save more in 2025 to pay for eligible health care expenses tax-free. HSA contribution limits will increase to \$4,300 for individual coverage and \$8,550 for 2-person and family coverage. If you will be 55 or older by the end of 2025, you can make an extra \$1,000 catch-up contribution.
